AFFIDAVIT

Principal of DAV public School, Sasaram-Ara Road Sema Birkamganj, Rohtas (Bihar) do hereby solemnly affirm and sincerely state as follows:-

1. That DAV College trust and Management Society is a registered society/Trust Under the Act XX106 1860 (Name of the Act under which society/trust is registered/Section).
2. That the DAV College Trust and Management society is of Non-Proprietary Character and DAV Public School, Sasaram-Ara Road, Semra, Bikramganj, Rohtas is governed by the society.
3. That the DAV Public school, Sasaram-Ara Road, Semra, Bikramganj, Rohtas is being run as a community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
4. That no part of income from the Institution is being and will be diverted to any individual in the Trust/Society/School Management committee or to any other person/entity. The saving, if any after meeting the recurring and non-recurring expenditure and contributions to developmental, Depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.
5. That the school is not playing any charge towards using name, motto, logo or any other non academic activities to any other institution, organization or body.
6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and not use CBSE name in any manner without obtaining affiliation.
7. That the Principal and correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination bye-laws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination bye-laws, directions issued from time to time and the laws of the land.

8. That the school will ensure compliance of all statutory requirement like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.

9. That the school will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.

10. That the school will ensure that all required infrastructure is available with the school before starting classes.

11. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bye-laws are available with the school before starting classes.

12. That the school will follow the provisions related to fee contained in affiliation bye-laws and will disclose the details of the fee to the students/parents every year before the commencement of session without resorting to any hidden charges in the heads of fee.

13. That the school will not coerce any student/parent to buy books / stationary / uniform from any particular shop.

14. That the school shall strive to make efforts for conservation of environment.

15. That the school will ensure that the school fulfils all essential requirement before applying for affiliation and will fulfill all other conditions post affiliation and comply with all the general rules as given in the affiliation bye-laws or not fled from time to time.


